- a. **Analytical/Performance cookies (optional):** These cookies may collect information anonymously on how visitors use our site. We only use these cookies with your express consent.
- b. **Functionality cookies (optional):** These may be used to recognise you when you return to our website. For example, to greet you by name and remember some of your preferences such as your region or language. We only use these cookies with your express consent.
- c. **Marketing cookies (optional):** These cookies may record your visit to our website, the pages you have visited and the links you have followed. We will use this information to make our website and the advertising displayed on it more relevant to your interests. We only use these cookies with your express consent.

## 3 Blocking & Deleting Cookies:
